PROPERTY SKETCH

Any person found guilty of violating a municipal Ordinance shall be subject to one or more of the following penalties: 1) A fine not to exceed \$1000.00. 2) Imprisonment for a period not to exceed ninety (90) days.

Disposal of Debris: It shall be the responsibility of the property owner/contractor to arrange for the proper disposal of all debris. The debris, (tree trunks, limbs, branches) is not permitted to be left at curbside for scheduled Brush Pick-up.

Possession of Permit: Any person(s) undertaking the removal of any tree(s) pursuant to this permit, must have this permit in their possession at the time that the work is actually being performed, and must immediately present the permit upon demand.
