**RESOLUTION 69-06**

**A RESOLUTION CERTIFYING THE TAX LEVY FOR THE LENAPE REGIONAL SCHOOL DISTRICT FOR THE 2006-2007 SCHOOL YEAR**

**WHEREAS**, the proposed School Budget of the Board of Education of the Lenape Regional High School District, County of Burlington, State of New Jersey, was defeated by the voters of Medford Lakes at the annual election; and

**WHEREAS**, the Board of Education of the school district delivered the rejected proposed budget to the Borough Council as required by law; and

**WHEREAS**, the Borough Council has consulted with the Board of Education and has reviewed the school budget and desires to certify the amount necessary to be appropriated.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough Medford Lakes, County of Burlington, State of New Jersey that certain revisions be made to the 2006-07 Budget of the Lenape Regional Board of Education as follows:

That the Borough Council of the Borough of Medford Lakes certifies the tax levy of \$85,564,836 for the Lenape Regional High school District. This represents a tax levy reduction of \$1,300,000 from the specified line items as listed on the attached forms.

It is hereby certified that, in the opinion of the Borough Council of the Borough of Medford Lakes, the budget is sufficient to provide a thorough and efficient education for the students of the Lenape Regional School District.
