Borough of Medford Lakes Vacant Property Registration Application

Effective March 24, 2016, Chapter 56 of the Medford Lakes Code requires the creditor/owner of any vacant property to register within thirty (30) days after the building becomes vacant or within thirty (30) days after assuming ownership of vacant property, or within ten (10) days of receipt of notice from the Borough of Medford Lakes of the need for registration. The annual renewal shall be completed by January 1st of each year. The initial registration fee shall be pro-rated for registration statements received less than 10 months prior to that date based on the number of months remaining in the calendar year. For example: six months before the end of the calendar year 6/12 would result in a \$250 first year fee.

- Initial Registration Fee: \$500
- First Renewal Fee: \$1000
- Second Renewal Fee: \$2500
- Any Subsequent Renewal: \$5000

Additional Registration Requirements

- The creditor/owner shall notify the Borough of Medford Lakes within thirty (30) days of any change in the registration informed by filing an amended registration statement
- The creditor/owner shall be required to renew the registration annually as long as the property remains vacant
- The creditor/owner shall be required to provide access to the Borough of Medford Lakes to conduct an exterior and interior inspection to determine the compliance with the Borough Property maintenance Code, following reasonable notice during the period of initial registration or any subsequent renewal
- The creditor/owner shall post a sign affixed to the building indicating the name, address, and telephone number of the creditor/owner, the creditor/owner's authorized agent for the purpose of service of process, and the person responsible for the day-to-day supervision and management of the building, if such person is different from the creditor/owner holding title or authorized agent. The sign shall be of a size and placed in a location to be legible from the nearest public street but shall be no smaller than 18"x24".
- *The following registration statement shall be deemed prima facie proof of the statements therein contained in any enforcement proceeding or court proceeding instituted by the borough of Medford Lakes against the owner or creditor/owner of the building.*
